The programme has been presented to the Cabinet Member for Transport & Environment. It is intended that this programme will be submitted for approval at the Council Budget & Council Tax meeting on the 13th February 2018.

The 2018/2019 Department for Transport (DfT) Structural Maintenance Block Capital Grant Settlement is £3.666 million which has been supplemented by:

A £272k DfT Pothole Action Fund Allocation;

A £808k Council Capital Investment;

A successful £2 million DfT Challenge Fund bid in partnership with Bristol City Council for the A4 Keynsham Bypass Maintenance Improvement.

Providing a £6.746 million programme of highway infrastructure investment across the network.

In terms of carriageways works, the funding allocated is allowing us to treat around 36.9 kilometres which constitutes 2.9% by length of our entire network. These improvement works are in conjunction with our on-going annual revenue routine and reactive maintenance works.
