### **26.01 APOLOGIES FOR ABSENCE**

### **26.02 DECLARATIONS OF INTEREST**

### **26.03 CONFIRMATION OF MINUTES**

That the minutes of the Events Committee meeting held on 7th October 2025 were approved as a correct record and signed by the Chairman.

### **26.04 EMERGENCY SERVICE DAY**

**Resolved** not to hold the event this year.

### **26.05 REMEMBRANCE DAY 8th NOVEMBER 2026**

The Paulton branch of the Royal British Legion (RBL) had been asked why the Remembrance parade is held on the afternoon in Paulton. The reason for this was that the clergy and concert band have commitments in the morning of Remembrance Sunday and could not take part in the Paulton service if it was held in the morning. This had been the case for at least 25 years and veterans also prefer that the service take place in the afternoon enabling them to attend other services in the morning.

**Resolved** to continue with the service in Paulton commencing at 2:30pm.

### **26.06 EVENTS DEBRIEF**

- Dressing the Graves 8<sup>th</sup> November 2025 – The event was a success, the RBL area in the cemetery could do with a tidy up. Agreed that Rev'd Pitt will conduct the service this year and Simon Memory will be the Commander in Chief.
- Remembrance Sunday 9<sup>th</sup> November 2025 – No incidents to report, Clerk will issue the Briefing Notes to the key people overseeing the event this year. The road closure request for 8<sup>th</sup> November 2026 will be submitted in the next few weeks. The introduction of the crosses for the Children to lay was a welcome addition and will be part of the service in coming years.
- Christmas Extravaganza on 29<sup>th</sup> November 2025 – the income and expenditure figures were reviewed with the Committee being very pleased with the results. Feedback including the times, advertising etc were discussed.

**Agreed** that the event for 2026 will be from 2:00pm until 7:00pm provisional on Saturday 28<sup>th</sup> November 2026. The Committee will look at activities for this year.
