278. CONFIRMATION OF MINUTES

Resolved – that the minutes of the meeting held on 3rd April 2018 were confirmed as a true record and signed by the Chairman.

279. CONSULTATION ON PLANNING APPLICATIONS

(1086) 18/01562/FUL – Hill Farm, Phillis Hill, Midsomer Norton.

Erection of Rural Workers Accommodation Unit.

It was proposed to support the application with conditions. A vote was taken but this fell. A second proposal was to object. **Object - outside the housing development boundary. It is a temporary structure being replaced with a permanent building and there are concerns over the requirement for permanent occupation.**

Meeting suspended at 7.12pm to allow a question from a Councillor in attendance. Meeting continued at 7.13pm.

(1087) 18/01884/AR – Tesco, Old Mills, Paulton. Display of 2no. vinyl graphics. **No objection.**

(1088) 18/01813/FUL - 63 Elm Road, Paulton.

Erection of first floor rear extension. Comments – it is not clear from the block plan and map what exactly is proposed. The garage is missing on the block plan and it is thought that the maps are out of date.

284. PARISH AND TOWN SITE ASSESSMENT TRAINING

Background - B&NES is preparing a new Local Plan through which the Core Strategy is being reviewed. The new Local Plan is being prepared alongside the West of England Joint Spatial Plan which will provide a new strategic planning context for all four West of England Districts 2016 – 2036.

Parish Involvement - B&NES is providing the opportunity for Parish Councils to be involved in working on the Local Plan by assessing HELAA sites to help inform which sites, if any, should be allocated in the Draft Local Plan. A Site Assessment Toolkit has been prepared to enable Parish Councils to undertake assessments of potential sites in their parish, which will be used to help draft the Draft Local Plan.

Timetable - Autumn 2018 – Local Plan Options Consultation (options for the location of new housing sites). May/June 2019 – a Draft Local Plan for public consultation.

Training – the training was looking through a 'local character toolkit' to assess the suitability of a site (or not) for development. We looked at:

- Understanding the landscape setting natural and visual factors important nearby hills
- 2) Understanding the built settlement land use around the site lay out of roads
- 3) Understanding bulk character areas types of dwelling

Issues to look at

- Site land forms that could influence the potential allocation of sites flat/steep/historic remains
- Water and drainage on site
- Views distinctiveness important to the identity of the place (ours the Batch, Boxbury Hill)
- Vegetation historic hedges, trees
- Ecology habitats of animals/birds
- Walking to local facilities

Conclusion – the aim of the day was to prepare Councillors for assessing HELAA sites by training those present on how to use the Local Character Toolkit.
