The Parish Council have recently received £2,660 from the Community Empowerment fund which has been earmarked for this project and will be added to the £10,000 that was agreed in principal subject to the full council agreeing the funding in the 2018/2019 budget.

The Scout and Guide Community hall is on the periphery of the Miners Rec and is the base for the various sections of the Scouting and Guide movements. It is also used by many other community groups, messy play being one of them.

Paulton Bowls Club also have wonderful facilities in the Miner Rec and have a very enthusiastic membership of 60 plus. They are pleased to welcome new members of all ages and abilities whether they want to play socially or competitively and are now able to offer disabled players the chance to join in.

The Miners Rec is beautifully maintained by Paulton Parish staff members, Paul and Mark and they must be very proud of their achievements.
